

APPLICATION FOR DRIVEWAY LINE MARKING

Before applying for driveway line marking, please read the following notes:

1. Application can be made to Council to mark driveway lines to better delineate the driveway and discourage illegal parking. Please note that this option only serves to better highlight the driveway. The marking of lines on the road to delineate a driveway has no legal standing in the event of a vehicle overhanging these lines.
2. The installation of the lines must not remove any on-street parking spaces.
3. The driveway is not on a State Road. The driveway is a Council approved crossing which is constructed to Council's specifications.
4. Provision of this service is subject to a fee set out in Council's Fees and Charges available at www.strathfield.nsw.gov.au.
5. Council has no obligation to replace line marking in the future. The resident/property owner is responsible for the cost for Council to install or reinstate the damaged or faded line marking.
