7 Application fee

Any business or person who makes food for sale must comply with the requirements of the Food Act 2003 & the Food Safety Standards, and must register with Strathfield Council if the premises where food is handled or prepared is in the Strathfield Local Government Area.

The following business are required to register but are exempt from paying the registration fee.

- Low risk food businesses.
- Not for profit organisations such as charities and local sporting associations.
- Business operating a medium risk home based food business as part of a sausage sizzle or community barbeque.

A home based food business is considered low risk if it handles only non potentially hazardous food, OR, if the business meets all of the following criteria:

- it does not produce food that has a very high level of inherent risk and a potentially unreliable critical control point (e.g. raw egg foods such as aioli and mayonnaise),
- it does not supply food to vulnerable populations or businesses that service vulnerable populations (e.g. aged care facility)
- it has at least one certified Food Safety Supervisor appointed by the business (if required),
- it produces less than 10kg of food for sale per week from the domestic kitchen (equivalent to forty 250g serves), and
- it notifies the local enforcement agency if any of these circumstances change.

A home based food business is high risk if it does any of the following high risk activities

- prepares or supplies to vulnerable populations (e.g. childcare facility that prepares food on site for children including home based childcare preparing PHF), or
- undertakes high risk processes/activities (e.g. raw egg products, smoking meats, sous vide), or
- large scale operations (e.g. function centre/large restaurant that employs more than 10 FTE food handlers).

All other businesses are considered medium risk.

Medium risk home based food businesses are required to register with payment of the registration fee.

Strathfield Council will not approve high risk home based food businesses.
